Dear Parents and Carers

PUPIL PREMIUM GRANT

As you may have heard on the news, schools receive additional funding called Pupil Premium Grant in relation to children whose parents receive certain benefits. This is currently £1320 per academic year per eligible pupil and your child would remain eligible for the next six years even after their parents benefits have ended. This means that even if you are only eligible for a very short period of time and you register for Pupil Premium grant, £7920 would be generated in funding for your child's school.

The additional money was used last year to fund extra TA support, to pay for school trips, free milk and additional teaching staff to keep class sizes low as well as paying for small group support. However, it is not automatically sent to schools, parents need to register for free school meals in order to qualify for Pupil Premium grant. This has caused confusion as children in Reception, Year 1 and 2 already receive free school meals. The important factor is registering if you receive any of the following benefits, as it is the entitlement which is important. This in turn enables the school to claim Pupil Premium grant.

- Income Support
- Income-based Jobseekers Allowance
- Income-related Employment and Support Allowance
- Support from NASS (National Asylum Support Service) under part 6 of the Immigration and Asylum Act 1999
- the guarantee element of State Pension Credit
- Child Tax Credit (**with NO Working Tax Credit**) with an annual income of no more than £16,190
- Working Tax Credit run-on
- Universal Credit.

I would be grateful if you would complete the form overleaf so that we may apply for Pupil Premium Grant funding for the school on your behalf. All information is treated in the strictest confidence and on a need to know basis only.

Thank you for helping to make sure that as a school we receive the correct funding entitlement. This in turn has a positive impact on the children's learning and on their whole school experience.
